

2023 Spinach Field Day at Tiro Tres Farms

Crystal City, TX 2/22/23

On February 22nd approximately 100 guests from all over Texas, the United States, and out of the country joined local producers for their annual Spinach Field Day hosted by Tiro Tres Farms, Crawford Farms, and The Wintergarden Spinach Producers Board in Crystal City, TX. In attendance were persons involved in various



occupations of agriculture, ranging from seed breeding to crop protection. The purpose of this field day was to showcase seed producers' products, conduct various research trials, and was even an excellent opportunity for pesticide applicator license holders to gain credit hours.

The field day consisted of a tour overview of research trials presented by Dr Larry Stein, Dr Kimberly Cochran, Dr Carlos Avila, Mike Phillips, Lindsey Du Toit,



and Kayla Spawton. The spinach varieties were each exposed, or *inoculated*, to three types of fungus: Stemphylium, Anthracnose, and White Rust. Stemphylium, *Stemphylium vericarium*, is a fungus that causes leaf spots that turn a tan color as the disease progresses. Anthracnose, *Colletotrichum dematium*, is a fungus that causes water-soaked lesions on both young and old leaves; the leaves to become thin. White rust, *Albugo occidentalis*, appears in spinach

as yellow lesions on the upper leaf surface, and as white, blister-like pustules on the lower surface of the leaves.

In addition to the fungal inoculation, Dr. Larry Stein and Mike Phillips conducted a fungicide trial for White Rust Control. This fungicide trial consisted of 16 treatments across 9 fungicides and were either used alone, in combination with others, or with surfactants. The fungicides used were Double Nickel (Cerits Biologicals), LifeGard (Certis Biologicals), Oso (Certis Biologicals), Reason (Gowan Company), Revus (Syngenta), Neo (Syngenta), Timorex (Syngenta), Merivon (BASF), and Veltyma (BASF).
